Trading Authorization
Limited to Purchases and Sales of Stocks and Options

The Investment Newsletter or Advisory Service(s) ("Service") to which I/we subscribe from time to time provides written recommendations as to stock and/or options transactions or strategies, and said Service(s) has been instructed to furnish Stock USA Investments/Speedtrader.com, Registered Option Principal, with this same information to allow Speedtrader.com to better service my/our account.

This Authorization does not grant the above-designated Agent(s) full discretionary authority to trade in my/our account. This Authorization expressly revokes and replaces any existing trading authorization previously executed by me/us in connection with our account.

* In all such purchases, sales, or transactions, Agent is authorized to follow the instructions of the Service(s) to which I/we subscribed, and have identified to Agent, in every respect concerning the undersigned's account(s) with Agent. The Agent is authorized to act for the undersigned and in the undersigned's behalf, in the same manner and with the same force and effect as the undersigned, with respect to such purchases, sales, or transactions in the account(s).

The undersigned hereby agrees to indemnify and hold harmless Speedtrader.com and their agents and representatives from, and to pay Speedtrader.com and their agents and representatives, promptly on demand, any and all losses, cost or expenses incurred in connection with the use of this trading authorization, including any debit balance in the undersigned's account(s). This Authorization (including this indemnity provision) is in addition to (and in no way limits or restricts) any rights which Speedtrader.com may have under any other agreement(s) between the parties.

This authorization (including the indemnity provision) is a continuing one which shall remain in full force and effect until revoked by the undersigned by written notice or until Speedtrader.com receives actual notice of death of the undersigned (or if two customers sign, the death of either one) and shall inure to the benefit of Speedtrader.com and any successor firm or firms, and the assigns of Speedtrader.com or any successor firm or firms. The laws of the State of New York shall govern the terms of the Authorization. The undersigned acknowledges that in acting or purporting to act under this authorization, the Agent will be solely as my/our agent and not as an independent agent of Speedtrader.com.
